Initially I worked in Corporate Services
Division (CSD) in the Recruitment unit.



While I enjoyed my time in CSD,
the opportunity to become a Dog Handler
was one I could not pass up and in 2018
I was successful in an internal Dog Handler
competition. I travelled to Wales for
6 weeks to undertake intensive
Dog Handler training.



The role itself was hugely rewarding. I could be deployed anywhere, depending on operational requirements, working with a drug/cash dog assisting in searches in Dublin Port/Airport, Rosslare Euro Port, Cork Port/Airport involving passengers and vehicles as well as assisting An Garda Síochána in multi-agency operations and premises searches.





I learned so much as a Dog Handler and have recently been promoted to Executive Officer working as part of the Detection Technology/ National Dog Program Unit. Working as a Dog Handler helped me enhance my important team leadership, communication and delivery of results skills.



I would highly recommend a career in the civil service to any teenager, and have done to my own son who's 17. There's ample opportunity to progress your career whether it's through lateral moves or via promotional competitions.

There are also opportunities to upskill, particularly in Revenue, where they offer diploma and degree courses in Taxation or provide a Refund of Fees scheme for people taking part in other courses to enhance the skills relevant to their role.

Executive Officers are involved in a wide range of roles and activities, including: researching and drafting proposals relating to policy issues and legislation; acting as junior managers in Government Departments; responsibilities for managing operations and, after some experience, large numbers of people and other resources; dealing directly with the public in support of services provided to them by the Civil Service. Executive Officers are employed in all Government Departments/Offices covering a wide range of functional responsibilities. The Executive Officer grade is the entry level to junior management in the Civil Service.
